DIRECTOR'S ACTION

The Director of Planning, by her action of March 6, 2024, has **APPROVED** the abovereferenced Project pursuant to County Code Sections 22.44.940.E, 22.44.940.G and 22.44.1020. The appeal period for this ACDP ended on February 27, 2024.

PROJECT DESCRIPTION

The Project authorizes the construction of 21 roof-mounted solar modules, appurtenant equipment, and associated wiring affixed to the existing single-family residence. The Project is located entirely within habitat designated as H3 (significantly disturbed). The Project is located within the existing building site area of an authorized development. The Project qualifies for a Class 3 (New Construction or Conversion of Small Structures) Categorical Exemption from the California Environmental Quality Act (CEQA) (Public Resources Code Section 21000 et seq.), the State CEQA Guidelines, and the Environmental Document Reporting Procedures and Guidelines for the County, because this exemption specifically applies to small structures associated with an existing single-family residence.
