Ray Huff - 1,3,5 tested and below emissions limit - flares What's in the gas? Not, CO(5), Methane, VOC Sulphur compounds, Particulate matter

Steve Cassulo - 8 locations of micro GC's being installed, more next month. Reaction - 44 acres, 235 wells installed, 93 pumps, 20 temperature probes. August 8 - west slope excavation project began to control drainage. Less water is coming out. Incident report - 3rd party pumper rolled over on Sunday, August 8.

John Perkey - document provided for community relief fund update. Report - community relief from March to July this year, 2024 provided over \$4 million in payments. Committee concerns about oversight committee and impact eligibility. Request for CEO of Chiquita Landfill to attend next CAC meeting.

2. **R-MAC - Response Multi-agency Coordination Group** (USEPA, CalEPA and LA County Fire) on scene response team.

Michael Broden with EPA - monitoring website is up at <u>CCLrealtime.com</u> and introduction to Joel Jones, US EPA who is replacing Thane.

Ben Castanetos - leachate went from 20,000 to 200,00 gallons/day. Presentation - leachate management, CCL producing more then what can be removed. 40.4 acres - liner installed since 2024

West tow scrim - 7/29 - 11/30 project for cap competition. Began on 8/8, safety meeting are at 7:30am and shuttled to work area.

State of Assembly, Pilar Schiavo - addressed level of support for the community. Local declaration request for Cal/OES best route.

4. AQMD - Update from Department of Toxic Substances Control - California EPA

Larry Israel - August 1478, 20 violations, 400 complaints since September 1-10 2024 - 14,690; 143 Hearing continued to November 2024, request for stipulations agreed to at hearing

Nikki Q - Community benefit fund moving forward, no sustainative updates but here for questions. Community request for when opening part of the skim to provide notification of hazmat trucks in the area.

David Neil, Chief council for Governors Office with Cal/OES - introduction and addressed State of Emergency - Open Proclamation - Emergency Services Act.

State Agencies sent a letter to close the landfill and ask for a state of emergency but received no response.
