Location: Unincorporated communities of Ladera Heights and View Park/ Windsor Hills, Marina del Rey, Ballona Wetlands, West LA/Sawtelle VA, West Fox Hills (Del Rey), Franklin Canyon, and Gilmore Island.

General Description of Proposal:

The Project consists of the Westside Area Plan (WSAP) and the associated amendments to: (1) the General Plan and its accompanying Land Use Policy Map; and (2) Title 22 (Planning and Zoning) of the Los Angeles County Code, including the zoning map, collectively known as the Project. The WSAP is a component of the General Plan that guides development in the seven unincorporated communities within the Westside Planning Area over the next 20 years. The Project implements the goals and policies and maintains consistency with the General Plan. The Board will also consider the certification of the Program Environmental Impact Report (PEIR), which includes the Final PEIR and Draft PEIR; and adoption of the CEQA Findings of Fact, Statement of Overriding Considerations, and County Mitigation Monitoring and Reporting Program.
