

NOTICE OF PREPARATION OF A DRAFT ENVIRONMENTAL IMPACT REPORT AND PUBLIC SCOPING MEETING

DATE: April 6, 2026

TO: State Clearinghouse, Responsible Agencies, Trustee Agencies, Organizations and Interested Parties

SUBJECT: Notice of Preparation of a Draft Environmental Impact Report in Compliance with Title 14, Section 15082(a) of the California Code of Regulations

The County of Los Angeles (County) is the lead agency pursuant to the California Environmental Quality Act (CEQA) and intends to prepare a Draft Program Environmental Impact Report (PEIR) for the Los Angeles County San Fernando Valley Area Plan Project (Project) described below. The County has prepared this Notice of Preparation (NOP) to provide Responsible Agencies and other interested parties with information describing the project and identifying potential environmental effects of this Project proposed for study in the PEIR pursuant to State requirements.

All interested parties, including the public, responsible agencies, and trustee agencies, are invited to provide comments and input on the scope and content of the environmental information and analysis in the Draft PEIR. Responsible and trustee agencies should provide comments and input related to their agencies' respective areas of statutory responsibilities in connection with the proposed Project. As a responsible or trustee agency, your agency may need to use the PEIR prepared by the County when considering permits that your agency must issue or other approvals related to this Project.

PROJECT APPLICANT: Los Angeles County

PROJECT LOCATION: The San Fernando Valley Planning Area is one of the 11 Planning Areas identified in the Los Angeles County General Plan (General Plan) and is bordered by

the Santa Clarita Valley and the Angeles National Forest to the north, and the Santa Monica Mountains Planning Area and Westside Planning Area to the south. The Ventura County line is the western border of the Planning Area, and the San Gabriel Valley and Downtown Los Angeles make up the eastern border. The San Fernando Valley Planning Area includes the following unincorporated communities of the County: Kagel and Lopez Canyons, Sylmar Island, Oat Mountain, West Chatsworth, Westhills, and Universal City. The San Fernando Valley Planning Area and its associated communities are identified in **Figure 1, Project Location**. Universal City is governed by an approved specific plan and is not anticipated to change. For this reason, the San Fernando Valley Area Plan focuses primarily on the Kagel and Lopez Canyons, Sylmar Island, Oat Mountain, West Chatsworth, and Westhills communities.

PROJECT DESCRIPTION: The San Fernando Valley Area Plan (proposed Project or SFVAP) is a community-based plan that focuses on land use and policy issues specific to the unique characteristics and needs of the Project area. The SFVAP is a long-range policy document that will guide long-term regulation of land uses in the unincorporated communities in the Project area through development of goals, policies, and implementation actions. The proposed Project would amend the General Plan to establish both areawide and community-specific goals and policies addressing land use concerns and issues. The SFVAP includes goals and policies addressing preservation of community character; open space and natural resource protection; historic preservation; protection of community health, safety, and general welfare; increased access to community amenities and other topics. The SFVAP would achieve these goals primarily through implementation of the following components of the Project, including, but not limited to:

General Plan Amendment No. RPPL2025000604. The General Plan Amendment would establish the San Fernando Valley Area Plan as a component of the County General Plan. The SFVAP would create goals and policies for the unincorporated area communities Kagel and Lopez Canyons, Sylmar Island, Oat Mountain, West Chatsworth, and Westhills. This new area plan includes the following:

- Areawide goals and policies with respect to the following topics, including but not limited to: Land Use, Mobility, Conservation and Natural Resources, Safety, Public Services and Facilities, Economic Development and Historic Preservation.
- Areawide Implementation Programs.
- Community chapters with additional goals and policies that are community-specific, addressing planning issues that are unique to a particular geographic community and cannot be addressed through areawide goals, policies, and programs.
- Updates to the land use policy map using the General Plan Land Use Legend, which would:

- 1) Maintain consistency between zoning and land use policy.
- 2) Correct mapping errors, such as properties with two land use designations.
- 3) Revise Figure 7.3 of the Mobility Element to reclassify a portion of Kagel Canyon Road from Limited Secondary Highway to Local Road.
- 4) Reflect recent acquisitions of vacant parcels for open space conservation.
- 5) Convert properties within the Twin Lakes Community Plan from a “Rural Community” land use designation to an equivalent land use designation from the General Plan Land Use Legend.

Zone Change No. RPPL2026000988. The Zone Change would update the zoning map for the Project area to maintain consistency with the updated land use policy map, reflect recent acquisitions of vacant parcels for open space conservation, and correct mapping errors, including split-zoned properties.

Ordinance No. RPPL2025000605. The Ordinance would amend Title 22 (Planning and Zoning) to establish a Planning Area Standards District to create development standards that are applicable to all unincorporated communities in the San Fernando Valley Planning Area and would include community-specific standards as well.

POTENTIAL ENVIRONMENTAL EFFECTS OF THE PROJECT

As permitted by State CEQA Guidelines Section 15060(d), the County decided not to prepare an Initial Study and will begin work directly on the Draft PEIR because it has determined that a PEIR is required for the proposed Project. The PEIR will evaluate potentially significant environmental effects of the proposed Project, identify feasible mitigation measures that may lessen or avoid such impacts, and identify a range of reasonable alternatives to the proposed Project. The PEIR will analyze the following environmental topics:

Responsible and trustee agencies are requested to indicate their statutory responsibilities in connection with this Project when responding.

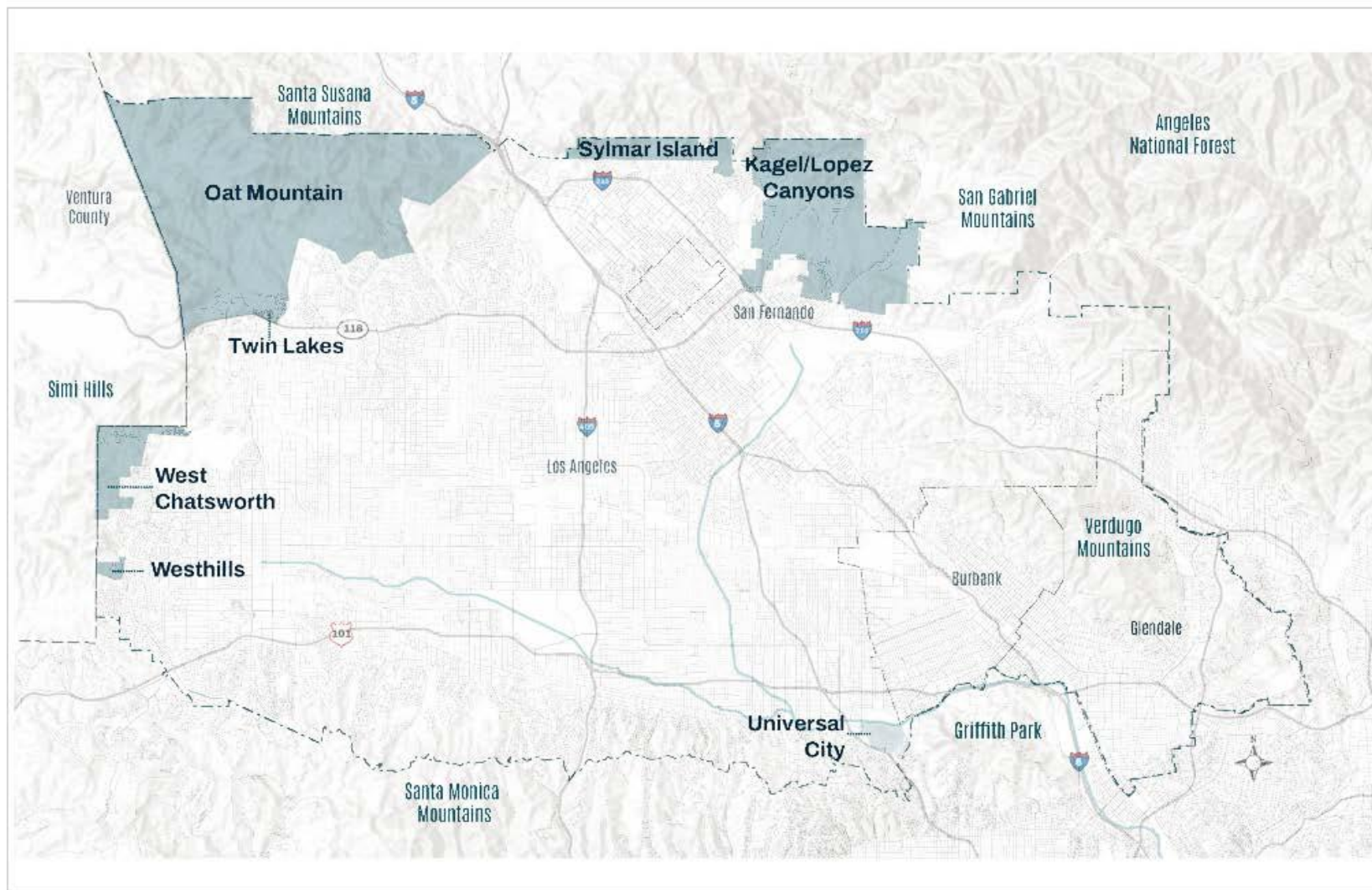
All written responses will be included as Appendices in the Draft PEIR and their contents considered in accordance with State and County environmental guidelines.
