



I have two significant concerns that must be addressed immediately: 1. The Regional Center must be relocated back to Westchester. It is unfair that they can decide where the center should be without discussing it with the other community. 2. If the need is genuinely for more housing, then Antelope Valley is ripe for development. I was walking the streets to campaign for someone running for public office, and I marveled at the undeveloped land. The justification is that having family members commute such a distance for work and to visit family members is unfair. People of Color have done so for at least three decades, and no one cared about our family members. Many moved to Antelope Valley and Riverside. Their jobs are still in Los Angeles. Others left the state. So, the only family members referred to are individuals who do not reflect the existing community. You want to scapegoat our residents, who had to pyramid up even to get here. No one was trying to make anything affordable for us; they made it more challenging.

The underlying agenda is to make it more comfortable for whites to live in the city. When the Westside became impossible, they ventured out to Pico and later south of Pico. Appraisers lowballed the property so they could buy low. The properties became more valuable once they became a more significant percentage of the area. Not because of what they had done to the properties but because of the color of their skin. Some believe we should not reside in properties like View Park, Windsor Hills, and Ladera Heights. This is evidenced by some representatives who attended one in-person meeting at Parent Elementary and the following Zoom meeting. We have prepared this letter to express our objection to the proposed zoning change of residential properties within the Ladera Heights community. Specifically, on the southside of Slauson Ave., the first three (3) residential parcels located south of the Slauson access road (little Slauson) to include each of the streets heading west from La Cienega to Wooster Ave., are proposed to change from R-3 H-9 to R-2 H-18. This change would allow for substantial development on these parcels and dramatically alter the appearance and character of this well-established upscale community.

With the exception of homes along the eastside of Chariton Ave, which does include some duplexes within the first block as you walk south, the remaining streets heading west along the southside of Slauson Ave. are characterized as having single family homes.
