- Baldwin Hills CSD Amendment Update Board of Supervisors Hearing Date: May 14, 2024
- 2023 Meteorological Station Annual Data Report
 - SPR meteorological station in compliance with CSD requirements.
 - SPR meteorological station for CSD compliance is not the same met station that CARB is using for the SNAPS project. Each SNAPS monitoring trailer monitors meteorological parameters.

D. Operator Update – Joe Walters

- Rigs Onsite
 - 3 Maintenance Rigs
 - 2 production and 1 injection well
 - o 2 Workover Rigs
 - 1 P&A on VRU 254
 - 1 on an injection well
 - Plug and Abandonments
 - Completed: TVIC 69 and VRU 111
 - In Process: VRU 254
- Spill Drill
 - Conducted and completed on 4/24/24. CA Fish and Wildlife, Office of Spill Prevention and Response (OSPR), and local fire department CUPAs participated and reviewed spill drill performance.
 - The OSPR evaluator provided very high overall marks to SPR for the drill performance particularly on responsiveness and overall internal, regulatory, and stakeholder communications.
- Questions/Inquiries from 3/28 CAP Meeting
 - 2023 Annual EQAP Report (Rev1); Report was revised and resubmitted. Description for item no. 17 has been revised to address rig engine requirements for well reworking.
 - 2023 Abandoned Well Testing Report (Rev1); Page 5, Paragraph 1. The paragraph was correctly revised to reference the use of Summa canisters for sample collection.
 - Analysis and lab work is the same with either container method.
 - 2023 Abandoned Well Testing Report (Rev1); Appendix D, Last Page. The chain of custody (COC) is included in the Gas Composition and Isotopes Analysis Laboratory Report.
 - Cyber Security; SPR has cyber security policies and programs in place to avoid potential issues. As stated in the 2022 April CAP meeting, SPR does not publicize its cyber security software for cyber security purposes.
 - Inglewood Oil Field well count data; research indicates 1596 total wells, 751 plugged and abandoned, to be confirmed.
 - Idle well timeline, average time a well is idle; SPR will research and provide information at the next CAP meeting.
- Question on SCAQMD Rule 1148.1 Notice to the Public; need to be within 1,500 feet of the well scheduled for maintenance to receive the notice.

- Question on potential re-use of a plugged and abandoned (P&A); very unlikely because the P&A wells have a 125 foot cement plug which would need to be drilled through. SPR commented that drilling a new well would be the simpler and preferred approach.
- Question on water injection activities and ground movement; is there a correlation between injection and horizontal ground movement? SPR to research and respond.

E. CHAAP Health Assessment Working Group – Ha Luong - UCLA

- Six month extension on the study has been requested and is in process.
 - Additional month of recruitment for data collection.
- Report completion date revised to October 28, 2024.
 - Presentation on the report and findings scheduled for September 2024 CAP meeting.
- Data Analysis continues.
- April 2024 CHAAP meeting was a hybrid in person/zoom event.
- Next CHAAP meeting May 16, 2024.
