# LAND ACKNOWLEDGMENT STATEMENT

**1.** The Land Acknowledgment Statement was led by Commissioner Duarte-White representing the First Supervisorial District.

Further, disruptive behavior communicated to the panelists of the meeting, which include the Commission and County staff, may result in the removal of that person from the meeting by disconnecting them from the online connection.

Santa Monica Mountains Planning Area. 15 Minor CDPs to construct 15 new single-family residences, four of which would include detached guest houses, on 16 lots in the R-C (Rural Coastal) Zone within the Santa Monica Mountains Coastal Zone. 12 Variances are also requested to allow onsite wastewater treatment systems (OWTS) within the 50-foot native tree buffer and/or the 150-foot riparian buffer, to allow habitable accessory structures within the H1 Buffer and H1 Quiet Zone habitat categories and to share OWTS with the primary residence, to allow structures that occupy more than 50 percent of the linear frontage of a parcel fronting a Scenic Route, and to permit structures within the required 100-foot buffers from parkland. No CEQA determination has been made for this project. No CEQA determination has been made for this project. Per State CEQA Guidelines and the Environmental Document Reporting Procedures and Guidelines for the County, a CEQA determination is not required when a project is denied.

Mr. Montgomery presented the project consisting of 15 single-family residences on 16 lots. Testimony was followed by Mr. Bill McKibbin the appellant, Mr. Michael Shonafelt and Mr. Daryl Koutnik, Consultants for the appellant, in favor of allowing the project to continue. A total of four speakers testified in opposition to the project and in support of the action to deny the project. Issues raised included destruction of sensitive habitat, light pollution, traffic, construction noise, fire hazard, proximity to wildlife, and interference of scenic views from the Backbone Trail.

# Action Taken as Noted

7. Project No. 2017-004054-(3). Major Coastal Development Permit No. RPPL2017006647. Planner: Tyler Montgomery. Applicant: Matt Gifani. 25740 Mulholland Highway. Santa Monica Mountains Planning Area. To construct a new 5,390-square-foot single-family residence, 725-square-foot detached carport, and new onsite wastewater treatment system (OWTS) with 5,182 cubic yards of grading on a 9.9-acre lot. The project is located in the R-C-20 (Rural Coastal — 20 Acre Minimum Required Lot Area) Zone in the Santa Monica Mountains Coastal Zone. The project is Categorically Exempt (Class 3 — New Construction or Conversion of Small Structures and Class 4 — Minor Alterations to Land) pursuant to CEQA reporting requirements.

Mr. Montgomery presented the project, followed by testimony by the applicants, Mr. and Mrs. Sam Afghani in favor of the project. A total of seven speakers testified, one member of the public spoke in support of the project, who was the son of the applicant and six with concerns, requesting for a continuance. The comments included the Department to ensure essential and relevant studies and reports are updated, conditions of approval are fully addressed, potential additional analysis are considered, and that trail easements across the Project Site have not been adequately addressed by the Department of Parks and Recreation.

In rebuttal, Mr. and Mrs. Sam Afghani, stated that no grading had been done to the property since 1971, they have cleaned up for fire season, the comment on the trail is not an actual trail and that 98% of said trail is on another property.
